I am directed to state that the Executive Committee of the Council of Architecture (COA) at its 265<sup>th</sup> meeting considered the application form at your institution, together with the information/ clarification provided by institution, for introduction of **2-year full-time Master of Architecture (Architectural Education) degree course** from the Academic Session 2024-2025.

Accordingly, the Executive Committee has decided, based on the reply furnished by your institution, is pleased to accord approval for introduction of the above said course at your institution as under:

2-year Full-time M.Arch. (Architectural Education)	20	2024-2025

The approval accorded by the Council to your institution is subject to compliance of the Council Norms attached herewith as **Annexure-A**. The approval accorded to your institution shall be subject to appointment of adequate Faculty of Architecture at your institution as per Council Norms, prior to commencement of academic session 2024-2025. The institution shall be required to appoint faculty to fill up any vacancy, as may be required, within 15 days in case of any faculty leaving the institution.

The final observations of the Executive Committee are mentioned below for your information and compliance:

- The institution shall be required to appoint requisite number of cadre-wise faculty as per COA Norms for introduction of M.Arch. course and submit its compliance to the Council within a period of 3 months.
- Adequate and cadre-wise faculty must be recruited/maintained by the institution at all time as per COA Norms.



The institution shall initiate necessary remedial actions, if any, based on the observations of the Executive Committee & Inspection Committee and send its compliance/observations on the same for further consideration. The Council shall be at liberty to inspect the Institution at any point of time to verify the compliance made by the institution and to ascertain that the institution is imparting architectural course as per the Norms prescribed by the Council, from time to time. In case the institution is found to be imparting deficient education during 2024-2025, the appropriate action shall be initiated against it.
